In 2022-2023, RMFY received funding from Mecklenburg County's JCPC to provide small group mentoring services to referred/identified youth, many of whom would be considered moderate-to-high risk or who are already court-involved. The original contract was to serve youth in the Juvenile Detention Center North. However, DC-North closed in October 2022, requiring our services to be redirected to other youth. Three of RMFY's school sites (Martin Luther King Jr. Middle, Thomasboro Academy, and Ashley Park Academy) were identified as the new JCPC sites. While our efforts were successful with the youth we were able to serve, we found that the language and forms required by the Department of Public Safety and Mecklenburg County's JCPC were not well-received by parents. As a result, we were unable to serve as many youth as we had hoped. As such, RMFY decided not to renew our initiative with JCPC for the 2023-2024 school year
