THE ROOSEVELT CENTER IS OUR LARGEST CAPITAL PROJECT. IN 2019 THE CENTER HOSTED MANY COMMUNITY EVENTS, INCLUDING PLAYS, MUSICAL PERFORMANCES, COMMUNITY DISCUSSIONS AND ART SHOWS. WE FURTHER TRANSFORMED THE OUTDOOR SPACE INTO A COMMUNITY GREEN SPACE FEATURING WALKWAYS, BENCHES AND AREAS FOR GROUPS TO GATHER, SCULPTURES, AND LANDSCAPING WITH NATIVE PLANTS. WE ARE AVIDLY FUNDRAISING SO THAT WE CAN INSTALL FIRE SUPPRESSION AND ALARM SYSTEMS SO THAT WE CAN OPEN THE HISTORIC 3RD FLOOR. THE 3RD FLOOR IS THE REASON THE COMMUNITY WANTED US TO SAVE THE 1920'S PORTION OF THE BUILDING. THE 3RD FLOOR INCLUDES THE HISTORIC STAGE, NOW CALLED THE GREGORY T. HARPER RECITAL HALL.

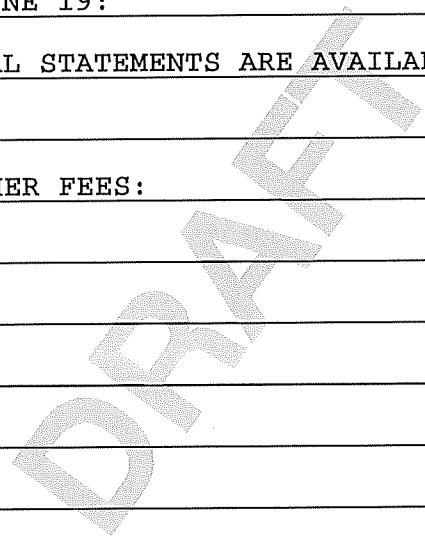
