

General Programs: The Nonprofit Center advises nonprofits on best practices and offers referrals, coaching, research, publications and communication vehicles, such as A List Serve. Our focus is on connecting Nonprofits to resources.

Awards Breakfast: An annual celebratory awards program to recognize and encourage individuals who work tirelessly to serve the Berkshire community. Nominations are solicited from across the Berkshires in eight categories. Honorees are selected by a committee of business, nonprofit and civic leaders. Sponsorships are solicited from local and regional businesses and foundations to fund the event.

4c (Code:) (Expenses \$ 6,284. including grants of \$ 7,500.) (Revenue \$ 7,005.)

Giving Guide: A printed publication designed to connect nonprofits with would-be donors and volunteers. All 1000 nonprofits in Berkshire County are listed free in the directory by category. Nonprofits that elect to have full page profiles pay \$80-\$130 for the extra exposure. Informative articles written by local nonprofit executives are also included.

The Guide is used by schools and camps to facilitate community service projects for students, by Giving Circles to identify charities to donate to, and by organizations such as Elder Services to place Seniors in nonprofit workplaces.

Thanks to our sponsors and advertisers, 14,600 copies of the Giving Guide were distributed free in partnership with Berkshire magazine.

Philanthropy in the Schools: A philanthropy curriculum in local middle schools and high schools was launched with a spring 2020 pilot program. Customized lesson structures that tie into core curriculum requirements are supported by teachers and administrators. Students use the NPC Giving Back Guide as a tool to identify nonprofits to assist. In our model, each student is empowered with a stipend of \$100 to give away, thus benefiting local nonprofits, especially as students explore how to leverage their gift to raise even more money for their chosen organization.

Fiscal Sponsorship: Designated as Model C, a pre-approved grant relationship. NPC accepts donations on behalf of the group that does not have its 503(c)(3) designation, and provide financial oversight until such time as they successfully get their designation. In exchange NPC takes a commission for the administrative work involved including receiving and depositing checks, writing thank you letters, issuing checks to the not-yet nonprofit, and providing oversight.

Workshops: The Nonprofit Center offers affordable educational workshops taught by local and regional experts.

Fourteen workshops were offered in 2020 including: Cultural Reflexivity and IDEA, Navigating Bias in the Workplace and Virtual Galas. Attendees made connections with each other as well as with the local presenters through these virtual and networking events and subsequently become resources for information and assistance at a later date.
