Campaign to STOP Genetically Engineered Trees - In August of 2020, the USDA published a petition to deregulate a GE American chestnut tree (D58), initiating a 60 day public comment period. GJEP coordinated and spearheaded the coalition effort to bring forth opposition to this petition, which resulted in historic numbers of people registering their opposition. The public comment period closed with 109 organizations representing millions of members, officially opposed to the proposal to plant the D58 GE tree in forests. Over 123,400 individuals also registered opposition to the GE tree during the public comment period. Another 400+ organizations endorse a full global ban on the release of all GE trees into the environment. GJEP coordinated and implemented an aggressive media campaign which included 5 press releases to 1,000 reporters and 3 press releases to the list of the Society of Environmental Journalists. This has paid off in more of our concerns and links to the white paper making it into articles about the GE chestnut. We organized an online press conference on October 20, 2020 to address the closing of the public comment period. Representatives of five organizations spoke out against the deregulation of this unprecedented GE tree: Anne Petermann-International Coordinator, Campaign to STOP GE Trees; BJ McManama-Campaign Organizer, Indigenous Environmental Network; Scot Quaranda-Communications Director, Dogwood Alliance; Dana Perls-Food and Technology Program Manager, Friends of the Earth; and Lucy Sharratt-Coordinator, Canadian Biotechnology Action Network.

If you have submitted a CHAR410 - Registration Statement for Charitable Organizations - but do not yet have a NY State Registration Number, check *NY Reg Pending*. If this is a final filing and the organization is seeking dissolution or ceasing operations, check *Final Filing* and submit all applicable IRS schedules and attachments. If your organization is a NY corporation, visit www.CharitiesNYS.com for information on how to dissolve. Check the Charities Bureau Registration Category of your organization (7A, EPTL, DUAL, or EXEMPT). EXEMPT organizations are those that have registered with the NY Charities Bureau and meet conditions in [Schedule E - Registration Exemption for Charitable Organizations](#) - but have registered and file voluntarily.

2. Certification

When you have completed the form, sign and print the name, title and date. For 7A and DUAL filers, the CHAR500 must be signed by both the president or another authorized officer and the chief financial officer or treasurer. These must be different individuals. EPTL filers have the option of a single signature if the certification is by a banking institution or a trustee of a trust. 3. Annual Reporting Exemption

You may claim an exemption from the reporting and fee requirements if you meet the filing exemptions applicable to your organization.
