THE SERIES INCLUDED ARTISTS FROM THE UNITED STATES, ISRAEL, THE UNITED KINGDOM, AUSTRIA AND FRANCE. TOTAL ATTENDANCE WAS 5,668. TWO SPECIAL EVENTS PRESENTED ARTS FROM CANADA IN A MORE INTIMATE VENUE.

EDUCATIONAL OUTREACH TO FOSTER APPRECIATION OF CHAMBER MUSIC AND REACH THOSE WHO MAY NOT OTHERWISE EXPERIENCE CHAMBER MUSIC. COMPLIMENTARY TICKETS TO AREA SCHOOLS AND UNIVERSITIES THROUGH A STUDENT VOUCHER PROGRAM ALLOWED 1,184 STUDENTS TO ATTEND A SERIES CONCERT EVENT. MASTER CLASSES WERE PROVIDED TO RICE UNIVERSITY MUSIC STUDENTS BY CANADIAN BRASS AND JERUSALEM QUARTET, AND ANOTHER CLASS WAS PROVIDED TO UNIVERSITY OF HOUSTON MUSIC STUDENTS BY MODIGLIANI QUARTET.
