FREE STREAMING CHAMBER MUSIC CONCERTS WERE OFFERED TO THE PUBLIC BY CMH WHEN IN-PERSON LIVE CONCERTS WERE CANCELLED, DUE TO THE PANDEMIC. COLLABORATING WITH OTHER CHAMBER MUSIC ORGANIZATIONS THROUGHOUT THE COUNTRY, CMH WAS ABLE TO PRESENT DIGITAL CONCERTS FROM THE CHAMBERMUSICHOUSTON.ORG WEBSITE, ABSORBING THE COSTS AND ENSURING THAT FREE, PUBLIC ACCESS WAS AVAILABLE.
