gospel of Jesus Christ. We serve refugees from more than 20 countries resettled in the DFW area from ages 0-88 by emphasizing
education, acculturation, and the Christian gospel message through ESL classes, literacy, tutoring, preschool, citizenship classes,
Bible studies, life skills, reading programs, field trips, and seminars. We also help connect refugees to food, clothing, and health care.

English Language and Literacy Classes: For the Nations provides free, quality English & literacy classes, which all include a
Christian gospel message. These classes are offered twice daily (M-F) and serve 360 refugees from more than 20 countries from
Africa, Asia, and the Middle East. Classes have excellent teachers and curriculum for English, literacy, and Bible teaching, which is
noted by student progress.

Summer Reading Program: For the Nations' summer reading program serves 350 elementary aged children from more than 20
countries daily for 8 weeks in the summer. The summer reading program includes English language learning, reading, math, art,
Christian Bible teaching, and educational field trips around Dallas. 215 volunteers give their time to help refugee children in the
summer through For the Nations.

Preschool: For the Nations provides free, quality preschool for refugees children ages 3-5. Preschool is offered twice daily (M-TH)
and serves 55 students from 15 countries. Classes have excellent teachers and curriculum, which includes pre-math & pre-reading
skills, art, fine and gross motor skills, and Christian Bible teaching.
