Wilderness Trek provides faith-based wilderness experiences. We are a backcountry guide service dedicated to leading people spiritually and physically through wilderness areas. Since 1976 we have guided over 30,000 teens and adults to become better disciples and leaders through multi-day backcountry experiences. Each year we have guided between 325-450 teens from multiple states and every major Christian denomination attended our camps. Attendance grew by over 348% from 2017 to 2019. In 2019 over half of the participants were new to the program. After the shutdown of 2020, we resumed our face to face programming in 2021.

* A new provision addressing the resignation and removal of a Director. The provision is consistence with Texas law requiring a Director to resign by submitting the resignation in writing. It also establishes the reasons the board may remove a Director from his/her position.

*Changed the vote requirement to amend the bylaws from a simple majority to two-thirds (2/3) of Directors.

*Changed the language to eliminate the staggered elections of directors and to establish an initial term of 3 years for a Director. Terms for officers were changed fromm 2 year terms to 1 year terms.
