Since 1976 we have guided over 30,000 teens and adults to become better disciples and leaders through multi-day backcountry experiences. Each year we guide between 300-450 teens from multiple states and every major Christian denomination. After the shutdown of 2020, we resumed our face-to-face programming in 2021 and had over 380 participants
