Thirty-two individuals with special needs were provided services in 2008, to include Respite and Personal Assistance (in-home supports). Nia received very high quality review ratings for two consecutive years by the TN Department of Mental Health and Developmental Disabilities auditors. It continues to receive excellent Financial Accounting Reviews and independent audits, highlighting terrific funds accountability. Nia is proud to announce the completion of its first "green" multi-family construction project. The building is composed of steel and structured insulated panels for optimal energy conservation. Current efforts include expansion of affordable housing and as-needed supports for ambulatory Veterans and Seniors.
