WEV IS A COMMUNITY DEVELOPMENT FINANCIAL INSTITUTION (CDFI) AND PROVIDES MICRO ENTERPRISE LOANS OF UP TO \$25,000 TO STARTUPS AND BUSINESS EXPANSION LOANS OF UP TO \$50,000 TO PRE-BANKABLE BUSINESSES. WEV SERVES BOTH MEN AND WOMEN IN ALL PROGRAMS. IN 2016, WEV PROVIDED TRAINING AND TECHNICAL ASSISTANCE TO 343 CLIENTS, PROVIDED 19 MICRO LOANS TOTALING \$270,018 & PROVIDED 1,664 HOURS OF CONSULTING TO 317 CLIENTS.

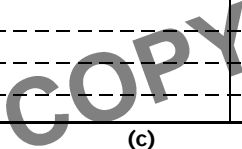

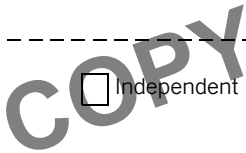
