2020 was a year of significant expansion for Rahab's Sisters. With the start of the pandemic we expanded our services to include men (in the parking lot) and set up hospitality and meal service in the host church's backyard as well. We served an average of 100 people every Friday. In addition, we added a camp outreach on Sunday afternoon, bringing hot meals, hygiene supplies, tents, tarps, and sleeping bags to approximately 180 individuals each week. Our mental health support both continued and expanded, with counselors on site every Friday as well as participating in Sunday deliveries and weekly phone check-ins for some guests as well as some volunteers.
