Other: Events and Outreach -- We sent 4 staff members to 38 tour stops across 51 days of outreach on Vans Warped Tour. We talked to 9,681 concert attendees, had 4,511 of them open up about their mental health struggles, spent 57,140 minute encouraging people face to face, and gave away 1,380 recovery programs to those we met. We built an 8'x16' physical version of our online forum, the Support Wall. This tool allowed 7 concert attendees to open up about their struggles every day and have 24 others from the concert that day write back on the wall to encourage them.

Other: Online Community and Technology -- Our 101k community members sent over 392k messages, and we saw an additional 5,301 people open up about their mental health struggles (on top of the 4,511 through outreach). We launched a new mobile-friendly version of our forum and saw an all-time high of over 11,000 replies to people in crisis. We live streamed on Twitch.tv 354 times for a total of 695 hours of real-time encouragement, during which we made over 200 video responses to topics on our forum -- that's the equivalent of making 50 full length feature movies of personalized video encouragement!

Other: Recovery Content and Programs -- We released two new recovery programs: one called Dwarf Planet that helps people overcome depression, and one called Mountains that helps people with vices and faith. In addition to ReWrite, our

program on self-harm that released in 2017, we sold 5,450 copies of our programs and gave away another 3,055 for free to those who needed it. We also sent 179 handmade Creative Encouragement packages to people who were struggling in our community, which included original artwork from a professional artist, a handwritten letter, and other small tokens to remind them of their worth. Lastly, we created 1,491 pieces of content that generated over 7.3m minutes of encouragement. In other words, our recovery content was encouraging 14 people round the clock 24/7/365.

Other: Part III, line 2 - The services in 4b and 4c have been central to HeartSupport's mission since its inception; however, this is our first time listing it on the 990. Below in schedule O, you can find statistics and accomplishments for these programs from 2018. And in Part III line 4b and 4c, you can find the definition of these programs.
