(RFK) RECRUITS, TRAINS, SUPPORTS AND MONITORS INDIVIDUAL CHURCHES THROUGHOUT THE UNITED STATES AND THE WORLD TO ENABLE THESE CHURCHES TO CONDUCT A ONE-WEEK, FREE SUMMER CAMP, AND A WEEKLY MENTORING AND MONTHLY CLUB PROGRAM. BOTH PROGRAMS ARE FOR FOSTER CHILDREN IN THEIR COMMUNITY, AGES 7 TO 11, AND BOTH ARE OPERATED IN ACCORDANCE WITH THE RFK POLICIES AND PROCEDURES, WHICH INCLUDE SPECIALIZED VOLUNTEER CLEARANCE AND TRAINING. THE CAMPS HAVE A COUNSELOR-TO-CAMPER RATIO OF 1 TO 2. OVER 7,700 FOSTER CHILDREN AND MORE THAN 11,000 VOLUNTEERS PARTICIPATED IN 209 CAMPS IN 40 STATES AND FOUR FOREIGN COUNTRIES IN 2015. OVER 100,000 FOSTER CHILDREN HAVE PARTICIPATED IN THESE CAMPS SINCE THE ORGANIZATION'S INCEPTION. FORTY-TWO MENTOR AND CLUB PROGRAMS OPERATED IN 10 STATES AND IN AUSTRALIA IN 2015. MENTORS WERE MATCHED WITH OVER 690 CHILDREN FOR FOUR HOURS PER MONTH OF ONE-ON-ONE MENTORING, WITH A SUCCESSFUL COMPLETION RATE OF 92%. A TOTAL OF 1258 ADULTS PARTICIPATED IN MENTORING AND IN MONTHLY CLUB MEETINGS DURING THIS SCHOOL-YEAR PROGRAM.
