IN 2018, 1MISSION BUILT 147 HOUSES FOR FAMILIES LIVING IN EXTREME POVERTY THROUGHOUT EL SALVADOR, NICARAGUA AND MEXICO. THESE HOMES PUT 542 PEOPLE IN SAFE AND DECENT SHELTER. THE FAMILIES COLLECTIVELY SERVED OVER 30,192 COMMUNITY SERVICE HOURS TO EARN THEIR HOMES, MAKING A HUGE IMPACT IN THEIR COMMUNITIES. THE SAFETY, SECURITY AND PEACE THAT IS PROVIDED BY ADEQUATE SHELTER ARE FUNDAMENTAL FOR A HEALTHY LIFE. THIS PARTNERSHIP IS CRITICAL FOR FOSTERING DIGNITY AND OWNERSHIP FOR THE HOME RECIPIENTS. IN 2018, OVER 4,248 PEOPLE FROM CHURCHES, BUSINESSES, SCHOOLS, AND OTHER GROUPS TRAVELED TO EL SALVADOR, NICARAGUA AND MEXICO TO HELP BUILD HOUSES ALONGSIDE THE LOCAL PEOPLE.
