THE FAMILIES COLLECTIVELY SERVED OVER 8,897 COMMUNITY SERVICE HOURS TO EARN THEIR HOMES, MAKING A SIGNIFICANT IMPACT IN THEIR COMMUNITIES. THE SAFETY, SECURITY, AND PEACE PROVIDED BY ADEQUATE SHELTER ARE FUNDAMENTAL FOR A HEALTHY LIFE.
