Hosted events such as RegTech Data Summit, a Research Symposium on Data and Evidence for Better Government; provided opportunities to bring leading experts from industry, academia, and government together to develop a shared understanding of challenges and solutions related to Evidence Act implementation; issued a compendium of insights and perspectives generated from the 2022 research symposium; issued a descriptive summary of results from a survey of federal chief data officers; encouraged improved data literacy and alignment with data governance strategies in the public sector, led the enactment of milestone legislation including the National Secure Data Service and the Financial Data Transparency Act; supported implementation of new transparency and data laws; and demonstrated new strategies for continuing to innovate with government data.
