ADDITIONALLY, THE CLINIC OFFERS AFFORDABLE VACCINATIONS, SPAY/NEUTER SURGERIES, MICROCHIPS, AND HEARTWORM TESTS FOR MEMBERS OF OUR COMMUNITY. IN 2021, OUR CLINIC PROVIDED OVER 135,000 VACCINATIONS AND OVER 9,000 SPAY/NEUTER SURGERIES. THESE AFFORDABLE HEALTH AND POPULATION CONTROL OPTIONS ARE ESSENTIAL FOR THE COMMUNITY.
