Enrollment is now up to 300 high school students. Phase Three was completed and preparations were laid for two additional classrooms on the second level and also long-range planning for Phase Four.

Partners also directly contribute to the support of individual residents providing clean clothes, fresh water, education, medical care, career training/opportunities, and spiritual empowerment.

4c (Code:) (Expenses \$ 74,203. including grants of \$) (Revenue \$) Orchard Project Fund: With the increase of children most at risk from trafficking, The Organization has focused on opening/expanding four Orchard Projects to address this critical need. Partners in 2017 generously gave towards the construction fund that will be used in 2018-2021 to accomplish these goals.
