Form 990, Part III, Line 4a: FLY's semester-long Law Program teaches youth about the law and

their rights, as well as the legal, social, and personal consequences of crime. It also helps

them learn life skills that lead to new coping strategies, and inspires them to change. In the

three counties in which FLY operates—Santa Clara, San Mateo, and Alameda—FLY's Law Program

served more than 2,500 youth in the community and in juvenile halls in FY17-18. Of these

youth, 98% report that the program gave them access to positive adult role models, 91% report

that they are less likely to break the law after being in FLY, 94% report that after the

program they are more likely to make healthier choices, and 96% report that the program has

given them more confidence to deal with negative peer pressure.

Form 990, Part III, Line 4a: When the Law Program ends, youth who are assessed as being at the

highest risk and having the least support are recruited to join the FLY Leadership Training

Program. Each youth completes a comprehensive assessment to identify their greatest barriers

to living a healthy, productive life. Together with a FLY case manager, who supports them

during the entire program year, the youth each create a plan to address these barriers. Two of

the most important measures of the success of youth intervention programs such as this one are

rates of recidivism (reoffending) and rates of high school graduation. National research data

shows that without effective intervention, 50% - 80% of youth released from detention will

reoffend, and that juvenile incarceration can decrease the chances of high school graduation

by up to 39%. By comparison, for youth enrolled in FLY's Leadership Training Program in all

three counties in FY17-18, 87% did not sustain a new offense during the program year and 75%

of eligible high school seniors graduated from high school or earned their GED.

Form 990, Part III, Line 4a: For more than 15 years in Santa Clara County, FLY has matched

youth on probation with trained adult volunteer mentors who support them in developing new

attitudes, behaviors, and ambitions. The program now includes a court advocacy component where

all mentors are granted legal standing to act as advocates for their mentees in the courtroom

and at schools. Called FLY's CAFA (Court Appointed Friend and Advocate) Mentor Program, it

operated exclusively in Santa Clara County. In FY17-18, 100% of youth reported that because of the Mentor Program they now have hope for their futures; 83% reported they are less likely to break the law; and 96% reported that they want to make positive changes after being in FLY.

restricted by the donor for use in FY 17/18. In FY 17/18, FLY released or expended an

additional \$465,000 of Temporarily Restricted Net Assets (TRNA) from prior years intended to
