A total of 45 traditional scholarships were awarded to graduating students attending Community College and/or Universities. A total of 10 students received assistance from our Student Assistance Program.

Classroom Grants for Special Projects:

After individual applications are approved by the Board, Classroom Grants are awarded to teachers for Special Projects such as Reading, Science, and Math Programs, Art Classes, and Equipment Upgrades. A total of 66 Grants were awarded to the local Elementary, Middle, and High Schools.

Enrichment Program for Kindergarten through High School:
