After individual applications are approved by the Board, scholarships are awarded to graduating students who will be attending higher education institutions. A total of 114 traditional scholarships were awarded to graduating students attending college and/or trade school. Installment payments on existing scholarships were paid out to 17 students.

Student Assistance Program -- K-12 & Post-Secondary:

K-12 Assistance provides basic needs for low-income students. Post-Secondary Assistance provides support for students chosen by each of the three Albany High Schools. Support includes mentors, school supplies, and financial assistance. Student Assistance Scholarships were awarded to 12 new recipients in June 2022. Existing Student Assistance recipients received 17 second installments.

Classroom & Enrichment Programs for Pre-K through High School:

The Classroom Grant and Enrichment Programs provide funds to our Schools to supplement their arts, PE/Health/Wellness, and STEM activities. Grant programs include the Big Impact Grant, Classroom Grants, Enrichment Grants, Special Circumstance Grants, Donor Designated Grants, Other Grants, STEM Grants, and Suicide Prevention.
