Today MYS offers 13 ensembles in orchestra, band, jazz and strings for young people of all experience levels and abilities, regardless of background or economic circumstance. MYS enrolls 400 school-age students in the greater Portland metropolitan area and SW Washington. In addition we offer a Beginning Strings Class, and introductory to advanced classes in music theory. Each season MYS holds at least 3 concerts at the performing arts center in downtown Portland and 9 concerts throughout the community.
