HISTORIC DEERFIELD OFFERS A BROAD RANGE OF PROGAMMING RELATED TO THE CORE AREAS OF ITS MISSION: HISTORIC PRESERVATION, MATERIAL CULTURE STUDIES AND NATURAL HISTORY. AS WITH OTHER ORGANIZATIONS, THE COVID-19 PANDEMIC FORCED HISTORIC DEERFIELD TO CLOSE ITS DOORS IN MID MARCH 2020 THROUGH MAY 2021. HISTORIC DEERFIELD IS A DESTINATION; ITIS MORE THAN SIMPLY TOURING A HOUSE OR ATTENDING A LECTURE.
