HISTORIC DEERFIELD OFFERS A BROAD RANGE OF PROGRAMMING RELATED TO THE CORE AREAS OF ITS MISSION: HISTORIC PRESERVATION, MATERIAL CULTURE STUDIES, AND NATURAL HISTORY. SINCE REOPENING AFTER THE COVID-19 FORCED SHUTDOWNS, THE MUSEUM HAS OFFERED A WIDE RANGE OF PUBLIC PROGRAMMING INCLUDING SUMMER EVENING STROLLS (WALKING TOURS) THAT HIGHLIGHTED DEERFIELD ARCHITECTURE, BURYING GROUNDS AND HISTORY. HISTORIC DEERFIELD IS A DESTINATION; IT IS MORE THAN SIMPLY TOURING A HOUSE OR ATTENDING A LECTURE.
