The project provided locally produced commodities to the selected food distribution centers & shelters, cooking and distributing meals to this migrant population in the Cúcuta-Pamplona humanitarian route. 63,882 Soup meals were distributed to Venezuelan refugees, migrants, and walkers "caminantes" through five major food distribution centers/shelters and 31 volunteers.
