WE HAD EIGHT TRIPS IN 2022, SEVEN TO DOMINICAN REPUBLIC (DR) AND ONE TO KENYA. THERE WERE 101 TEAM MEMBERS TOTAL. IN EL BATEY, DR, THE COMMUNITY CENTER WE BUILT TOGETHER IS BEING USED FOR VOCATIONAL TRAINING. THE PUBLIC SCHOOL IS USING THE TWO NEW CLASSROOMS COMPLETED BY FFP TEAMS THIS YEAR. THE COMMUNITY LEADERS HAVE REQUESTED A DAY CARE CENTER BE BUILT SO WOMEN CAN SAFELY LEAVE THEIR CHILDREN WHILE THEY WORK. THEY ARE ALSO HOPING TO PARTNER WITH THE GOVERNMENT TO APPROVE A MEDICAL CLINIC FOR THE AREA AND FFP WOULD FUND THE CONSTRUCTION OF THE BUILDING.

IF A CONFLICT OF INTEREST IS DETERMINED TO EXIST MANAGEMENT AND THE GOVERNING BODY WILL BE NOTIFIED IMMEDIATELY. THE MEMBER WILL NOT BE ALLOWED TO VOTE OR BE A PART OF ANY DECISIONS ABOUT ANY SUCH TRANSACTIONS THAT HAVE TO DO WITH THE CONFLICT UNTIL SUCH TIME THAT THERE IS NO LONGER A CONFLICT.
