RESPITE CARE AND INDIVIDUALIZED EMPLOYMENT SERVICE:

OSPREY VILLAGE WAS APPROVED AS A QUALIFIED SERVICE PROVIDER BY THE SC DEPT. OF DISABILITIES & SPECIAL NEEDS (DDSN) IN 2016 AND HAS BEEN PROVIDING RESPITE CARE AND JOB TRAINING SERVICES SINCE THEN. HOWEVER, ALL SERVICES WERE SUSPENDED AS OF JUNE 2021 DUE TO THE IMPACTS OF COVID-19 WHICH CAUSED THE LOSS OF MANY CLIENTS AND ALL OF OUR SERVICES STAFF; WE ALSO HAD MOUNTING FINANCIAL LOSSES DUE TO INSUFFICIENT MEDICAID REIMBURSEMENT RATES FOR OUR SERVICES. THE ORGANIZATION THEN RE-FOCUSED ITS EFFORTS ON DESIGNING AND IMPLEMENTING A HOUSING DEVELOPMENT PLAN FOR ADULTS WITH DEVELOPMENTAL DISABILITIES ON OUR 25 ACRES OF DONATED PROPERTY IN HARDEEVILLE, SC.

OSPREY VILLAGE APPLIED TO THE SC HOUSING TRUST FUND FOR CAPITAL FUNDING OF PHASE I OF THE HOUSING DEVELOPMENT PROJECT IN JUNE 2021 BUT WAS NOT AWARDED FUNDING.
