

THE HUMANE SOCIETY FOCUSED ON THREE MAIN PROGRAM AREAS: HIGH-VOLUME ADOPTION, LOW COST SPAY/NEUTER, AND PET RETENTION SERVICES. IN 2012, THE SOCIETY'S FACILITY WAS OPEN 6 DAYS A WEEK FOR ADOPTIONS WITH OVER 2,595 PETS ADOPTED. THE SOCIETY OPERATES A LOW COST SPAY/NEUTER CLINIC OPEN TO THE PUBLIC EIGHT TO TWELVE TIMES PER MONTH. IN 2012, THE SOCIETY PERFORMED 3,560 LOW COST SPAY/NEUTER SURGERIES. THE SOCIETY ALSO PROVIDES LOW COST PET WELLNESS SERVICES TO LOW INCOME PET OWNERS INCLUDING VACCINATIONS, WELLNESS CARE, AND EDUCATION TO OWNERS.
