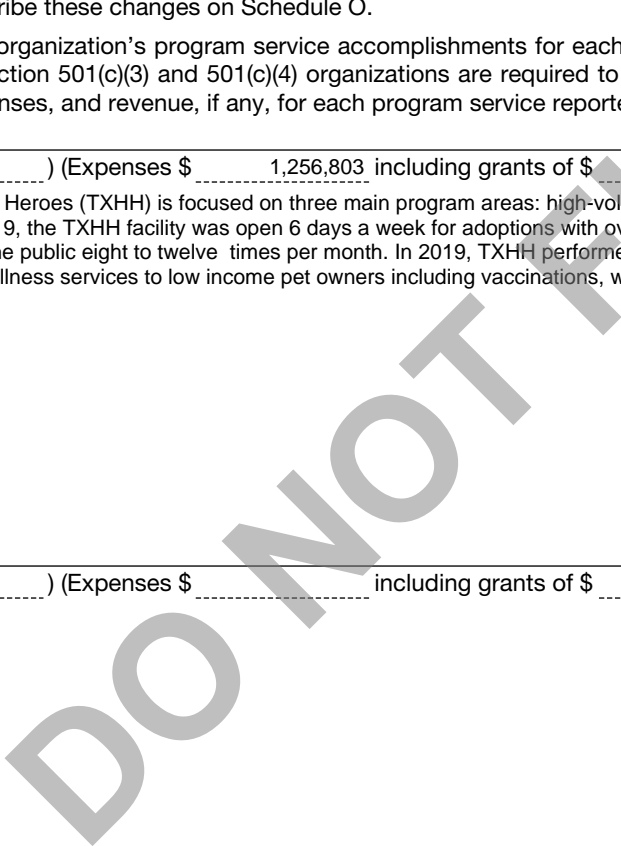
Texas Humane Heroes (TXHH) is focused on three main program areas: high-volume adoption, low cost spay/neuter, and pet retention services. In 2019, the TXHH facility was open 6 days a week for adoptions with over 3,117 pets adopted. TXHH operates a low cost spay/neuter clinic open to the public eight to twelve times per month. In 2019, TXHH performed 5,351 low cost spay/neuter surgeries. TXHH also provides low cost pet wellness services to low income pet owners including vaccinations, wellness care, and education to owners.
