Texas Humane Heroes (TXHH) is focused on three main program areas: high-volume adoption, low cost spay/neuter, and pet retention services. In 2018, the TXHH facility was open 6 days a week for adoptions with over 2527 pets adopted. TXHH operates a low cost spay/neuter clinic open to the public eight to twelve times per month. In 2018, TXHH performed 3,900 low cost spay/neuter surgeries. TXHH also provides low cost pet wellness services to low income pet owners including vaccinations, wellness care, and education to owners.

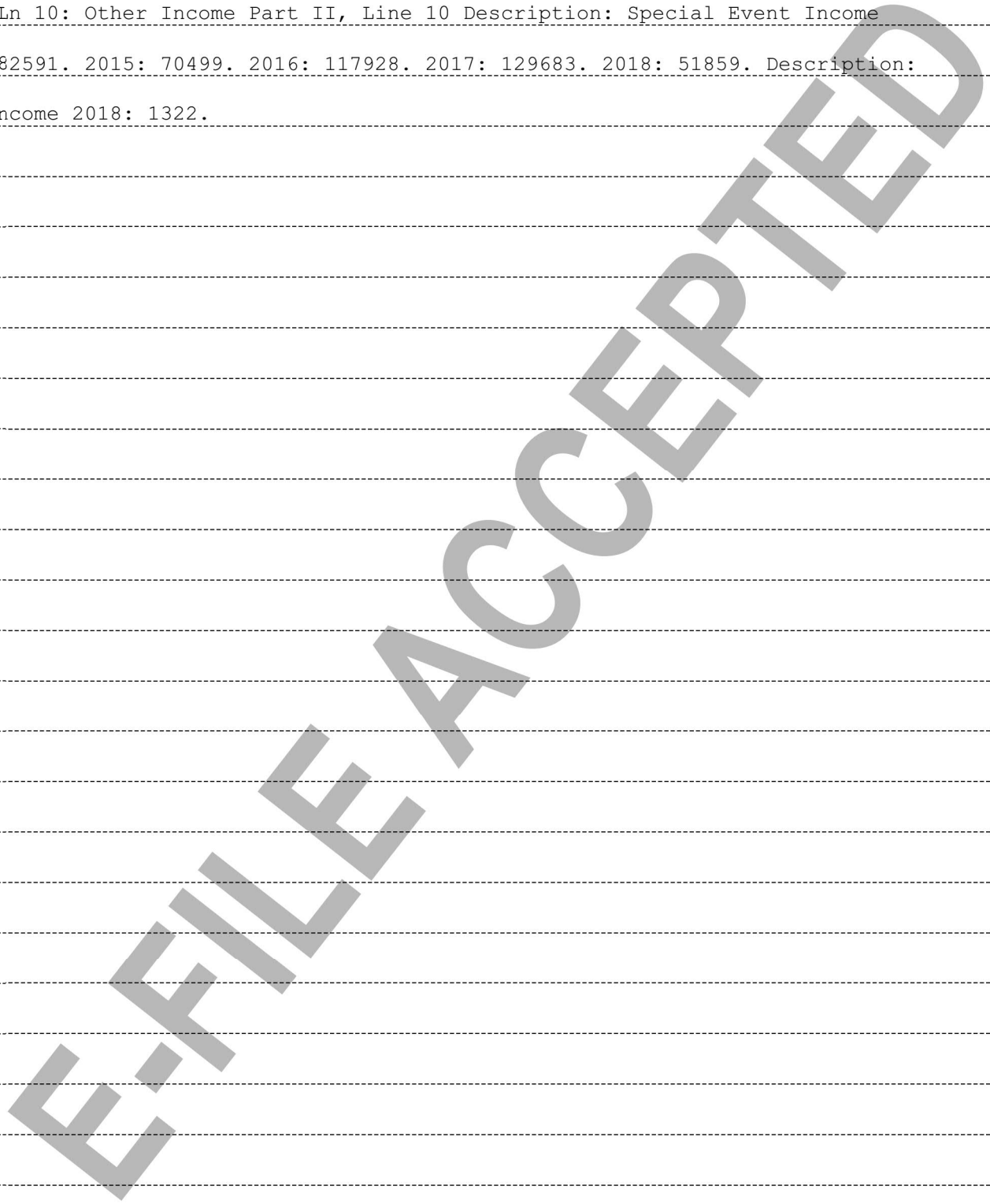
