Kupuohi Education Program Overview: Educational programs conducted throughout the year serviced public and private schools classes with students ranging from pre-k to university students. The aina based curricula is focused on fishpond ecology, fishpond traditions, and natural resource management. Students engage in hand-on science utilizing Loko Ea as a Living Learning Laboratory. Students experience meaningful science-based outdoor learning while initiating a sense of place and stewardship creating life-long learners and stewards.

Kulaiwi Nani Restoration Overview: MLEF host monthly community workdays, which allows volunteers to assist in the restoration, as well as maintenance activities. Stewardship activities focused on each of the 3 fish ponds, as well as maintaining and cleaning the auwai kai and makahas. Stewardship activities included the removal of invasive plant and fish species and sand removal from the auwai kai.

In addition due to COVID-19, Malama Loko Ea Foundation added an educational virtual learning experience since schools were shut down and teachers still wanted to "teachable" format to use with their classes.

Malama Loko Ea Foundation also added Community Engagement via a Community Imu in partnership with Kai'a'ulu Shore Food Bank to serve those most impacted by COVID.
