93A Prime Time/Childcare: Strengthening families and meeting the needs of children have always been central to the YMCA of Central Kentucky mission of building healthy spirits, minds, and bodies for all. The central focus of our licensed YMCA school-aged childcare programs is to foster growth and development, not only in children, but also in their parents and families. YMCA childcare curricula help children develop moral and ethical behavior, self-esteem, and leadership. Our commitment to quality includes participation in the governor's Stars for Kids Now initiative. YMCA childcare programs also help parents remain gainfully employed, knowing their children are thriving in a safe, supportive environment. The program also provides children and families with educational support, through the use of nationally recognized programs such as KidzLit and KidzMath and through tutoring. YMCA after school programs also participate in nationally known initiatives, such as the "Lights On After School" event. The YMCA of Central Kentucky provided licensed childcare at 26 separate sites throughout the school year, where approximately 1,140 children were served. In addition to after school childcare, the YMCA Prime Time program provides all day programs for children during snow days, holiday breaks and early dismissals, serving 334 children. YMCA financial assistance policies ensured participation for children of all economic levels, with \$114,380 in financial assistance distributed to those in need.

The YMCA of Central Kentucky also offers a state licensed, star-rated, developmentally appropriate Early Childhood Center at its North Lexington branch that serves children from infants through 5 years of age. Daily activities and the family involvement opportunities support the Kentucky Early Childhood Standards as we develop skills in each child that will prepare them for success in school. In 2007, 61 kids were served at this center. Financial assistance approximating \$34,000 was awarded to the families of these children.

93B Aquatics: YMCA aquatic programs are a part of the YMCA of Central Kentucky overall goal of building healthy spirit, mind and body. In addition to providing swimming instruction, competitive aquatics, water awareness programs, and lifeguard training, YMCA aquatics provide an outlet for exercise, therapy, competitive swim teams, and recreation. With three indoor pools, an outdoor pool, and an indoor warm water pool, our various facility locations provide outlets for a variety of aquatic programs within Lexington at fees that are affordable to all segments of the population. In addition to the operation of our own pools, the Jessamine County YMCA oversees the operation of the Nicholasville/Jessamine County Waterpark. In addition, the Jessamine County YMCA accessed other off-site locations to offer swim lessons for youth in the county. Over 6,500 people were registered in some form of instructional YMCA aquatic activity in 2007. In addition, 328 children participated in the YMCA's weeklong free water instruction and awareness program known as SPLASH. YMCA swim teams served 281 children, with parents involved with these teams logging over 700 hours of volunteer service. Fifty-three people received training to become lifeguards. Water exercise classes served over 2,000 on a monthly basis, including special classes for arthritic

individuals. With limited indoor aquatic space throughout the community, the YMCA serves as a resource for other area aquatic programs. The YMCA provides free space year-round to the Bell House Seniors for water aerobics, and provided practice space for four area high school swim teams. Our High Street YMCA provides its pool for preschool swim instruction for Central Christian Day Care and the Montessori School. We also provided free swim instruction for children from the Manchester Center. The Beaumont YMCA provides pool time for Fayette County Parks and Recreation Adaptive Aquatics programs, and the High Street YMCA provides pool space for the Special Olympics Swim Team. In addition, we provide pool training time for the Lexington Fire Department, and we also provided water training for 12 military cadets. As with all YMCA programs, financial assistance is available, and in 2007 over \$7,000 was provided in assistance for individuals to participate in YMCA aquatic programs.

93C Health and Fitness: According to the Surgeon General's Report on Physical Activity and Health, "physical inactivity is a serious, nationwide problem. Its scope posed a public health challenge for reducing the national burden of unnecessary illness and pre-mature death." The YMCA of Central Kentucky addresses this challenge by providing a variety of exercise programs for all ages in the atmosphere that advocates participation, not competition, while nourishing the social, mental and spiritual aspects of total well being. In addition to a variety of wellness programs offered within our YMCA facilities, the YMCA collaborates with outside groups on numerous health fairs including the Migrant Network Coalition Fair, the Roots and Heritage Health Fair, the Links Walk-a-thon, area businesses and churches. The YMCA also provides 8 Anger Management classes per week to female offenders and 12 classes per week for male offenders housed at the Fayette County Division of Community Corrections. In addition, the YMCA provides recreational and health opportunities for men living at the Hope Center and exercise programs for the Hope Center for Women and the Emerson Center for Seniors. The Senior Health and Fitness Day had 75 participants with classes and vendor tables. The YMCA also provides free exercise classes specifically designed for adults with Multiple Sclerosis, serving 20 different individuals in 2007. Through our partnership with Saint Joseph HealthCare, YMCA participants can participate in health screening activities, nutritional education and classes for people with specific conditions, such as diabetes. In 2005, the YMCA of Central Kentucky was selected by the YMCA of the USA as 1 of 22 YMCAs to participate in a national initiative known as YMCA Activate America. Our YMCA also partnered with the Governor's office to host the Get Healthy Kentucky 5K run. The YMCA provides specialized health and wellness programs, providing physical fitness training for our police officer recruits. The YMCA collaborates with numerous organizations in the community to educate, increase awareness and promote healthy lifestyles, collaborating and participating in programs such as Relay for Life, and providing training and programs in conjunction with area health departments. The YMCA provided college credit courses in self defense for the Bluegrass Community and Technical College. The majority of adults who join the YMCA do so because they wish to participate in some form of exercise, whether an organized class or an individual workout. The YMCA makes fitness accessible to the whole community by providing over 175 fitness classes weekly at Beaumont and 38 classes weekly at North, included free with membership, and by providing financial assistance for those that cannot afford to pay full fees. We also partnered with the Lexington Fayette County Urban Government to host Bike Lexington which attracted approximately 700 participants.

93D Youth and Teen Programs: A variety of youth and teen program activities (including sport skills, sports leagues, martial arts, movement education, youth/teen exercise programs, literacy and social gatherings) provide the framework for skill development, self-confidence, education, encouragement of healthy lifestyles and fun.

YMCA of Central KY youth sports leagues are based on the philosophy that "everyone plays; everyone wins". The objective of YMCA sports leagues is to improve physical health and self-confidence, foster skill development, teach teamwork, encourage the development of respect, honesty, responsibility, and caring, and above all, have fun. Our youth program focuses on progressive skill development through which everyone is given the opportunity to experience success on their own level. Every child plays in every game, and winning is de-emphasized. In 2007, 3850 children were registered in leagues. Family involvement is also an important aspect of youth sports. In both May and October the Soccer Extravaganzas each attracted more than 1,000 players and their families. Another very important component of our youth sports program is volunteer development. Our program relies solely on the use of volunteer coaches. In 2007 over 5000 hours were recorded. All of our volunteer coaches are encouraged to complete a sports specific orientation which includes developmentally appropriate communications, core values, and the NAIA's Champions of Character program and basic skill training. In 2007 the Toyota Bluegrass Miracle League served 125 children with special needs, and 50 adults in the new adult league. The YMCA operates the league which requires the recruitment and scheduling of players and volunteers. Each child in the program has a volunteer buddy who assists during each game. In 2007, 300 volunteers participated with this program.

The YMCA also offers a variety of other youth and teen activities. At the YMCA's free Fall Festival, over 750 children participated in safe Halloween activities between the Beaumont Centre Family YMCA and the North Lexington Family YMCA. 431 children participated in Healthy Kids Day activities; and Christmas gifts were distributed to 372 low-income children during 2007. During the Thanksgiving holiday, the Beaumont Centre Family YMCA hosted a 'YMCA Families Helping Families' coat drive, where we were able to provide over 250 coats for youth and families throughout the community. Free family events (magic shows, drive-in movies, family swim programs) are provided on a monthly basis, where members of the facility can participate in wholesome activities led by YMCA staff and volunteers. The continued decline of our children's health is an area that the YMCA is addressing with greater intention. Through our partnership with the Lexington Fayette County Health Department, the YMCA had partnered with the VERB Summer Scorecard campaign by providing free activities for teens to ensure that they remain active throughout the summer. Approximately, 125 people participated in the free Longest Day of Play event, which brought families together with fun, physically active games. The YMCA also continues its collaboration with the University of Kentucky Medical School and the Lexington Fayette County Health Department on a youth obesity prevention program for youth at Johnson Elementary school. This program, known as Jumpin' Jaguars, serves 30 youth and their families with physical fitness activities, free Y memberships, and health and nutrition education. With attendance ranging from 50-200 teens per month at our Teen Music Nights, teens are given the opportunity to play music for their peers in a controlled environment at the YMCA. With the guidance from Y staff, teens are educated on taking ownership of the YMCA as a venue to host music events by giving teens guidance on how to operate events in a safe atmosphere. In 2007, the YMCA of Central Kentucky led its first Youth

Government program at E.J. Hayes Middle School where students prepared and debated bills in front of their peers in Frankfort, KY at the Kentucky Youth Assembly at a three day conference. The Youth Arcade, an interactive exercise area for youth at the Beaumont Centre Family YMCA registered over 6,000 visits in 2007. The Arcade area provides healthy supervision for youth while their parents are working out in the YMCA facility. In 2007, our Scott County YMCA pioneered a boys club held once a month at the Royal Springs Middle School where youth can participate in safe after school programming.

Promoting literacy among youth is a major program focus for our Community Initiatives department. Over 6,000 books were distributed to youth and families in Central Kentucky, including low income and migrant families through the Wild About Reading program. The Y also hosted two reading events where families were encouraged to attend the Beaumont Centre Family YMCA in conjunction with the Lexington Public Library's Outreach program.

Teen camps provided an opportunity for teens to participate in community activities in a safe and supervised environment, and included sessions on team building, character development, volunteer opportunities, and provided teens with role models for leadership development. Such camps involved over 900 participants during 2007.

93E Others-Youth Camps: YMCA of Central Kentucky youth camping programs exist to provide education, promote spiritual awareness and mental development, physical health and well being, social growth, and respect for the environment. Through a variety of activities, YMCA camping seeks to help participants achieve their fullest potential in spirit, mind, and body while providing safe, high-quality care for children during summer months. During the summer months, all-day programs were offered at 15 sites throughout Central Kentucky including our Bar-Y Outdoor Camp, Prime-Time Camps, sports camps and specialty camp locations. These camps served over 1,576 participants. The YMCA specialty camps include camps in aquatics, horseback riding, fencing, soccer, and flag football. Financial assistance in the amount of \$104,201 was provided to children in camps.

93E Others- Arts and Humanities: As a means of providing healthy minds and spirit, the YMCA offers various arts and humanities programs to youth, teens and adults. Such instructional sessions are offered in various art forms including music (guitar and percussion classes), dance (ballroom dance and ballet) and visual art forms (drawing, water color and oil painting, clay sculpting), drama (theatre), and language programs (beginning, and intermediate Spanish). In addition, the YMCA of Central Kentucky runs an Arts outreach program for youth ages 12-15 entitled "Quest Drum Line" which is a performing musical ensemble. During 2007 Arts programs had approximately 480 program participants enrolled throughout the YMCA of Central Kentucky.

93E Others-Adult Programs: A number of programs were offered by the YMCA for adults (including senior adults), not including aquatics, health and fitness programs, or arts and humanity programs, discussed in the respective sections above. Such programs include adult sports instruction and sports leagues, including volleyball,

basketball, ultimate Frisbee golf, fencing, and tennis. Adult leagues at the YMCA encourage recreation and socialization. In 2007, 536 adults participated in dodgeball, basketball, and recreational volleyball leagues. Other programs included CPR and first-aid training, Parents Night Out offers parents time to pursue activities knowing that their children are in a safe and organized environment. The Beaumont YMCA Y's-Owls provide a free monthly pot-luck lunch for adults to meet and socialize with others. A "Drug-Proof Your Family" workshop was also held at the Beaumont YMCA for teens and adults. YMCA staff held parenting seminars at the North Lexington Child Development Center to help parents build parenting skills and to learn how to be a part of their child's development and education. Computer training was offered to low-income adults at the Black Achievers Center for Achievement.

93E Others-Black Achievers Program: The YMCA Black Achievers Program provides students in grades 7 – 12 exposure to present and future educational and career opportunities, instills positive social values, encourages a quest for knowledge and enables students to reach their fullest potential. The students are also connected with adult mentors. More than 475 students, representing 11 area counties, participated in weekly Saturday mentoring sessions throughout the school year and over 275 attended the Black Achievers College, Career and Health Fair event which is designed to help high school students understand future college and career options. The program provides ACT/SAT prep courses; organizes a "Give Back Day" in which 300 students participate in community service projects. In 2007, approximately 4,800 volunteer hours were recorded. A standard for YMCA Black Achievers is that the program remains financially accessible to any student wishing to participate. The fee for participation is only \$30 per year. YMCA Black Achievers also assists teens in making post-educational choices through college tours and college application assistance. Every senior in the program that goes through the scholarship process receives a scholarship and/or cash award to pursue post-secondary education. During the annual Black Achievers Banquet, 50 graduating seniors were awarded scholarships and cash awards totaling \$700,000. Volunteers are the foundation of YMCA Black Achievers. Adult volunteers mentor students every other Saturday throughout the school year and introduce students to businesses throughout the area. Twenty-four adults were formally recognized as Adult Achievers.

The YMCA Center for Achievement opened in April 2006 in a low-income area of Lexington and houses a complete computer lab, training/multi-purpose room and a recreation room for youth and teen enjoyment. Through this Center, the YMCA offers programs such as ACT prep classes, basic computer classes and after school tutoring. In 2006, the site was approved by the Kentucky Department of Education as a Supplemental Education site, providing tutoring for children referred specifically from schools that are not meeting criteria set up through the No Child Left Behind Act. The Center also partners with 5 Fayette County middle schools on a program called "Gear Up", which works to prepare students and their parents for the possibility of college. At the end of 2007 the YMCA Center for Achievement served 975 children and adults.

94 Membership: The YMCA is a membership association of men, women, and children who agree to cooperate with one another in the accomplishment of the mission and purpose of the YMCA: to put Christian principles into practice through programs that build healthy spirit, mind and body for all. YMCA membership brings people from various segments of our service area together, thus creating a sense of community among individuals who would otherwise never interact. YMCA membership is open to all people regardless of age, race, religion, ability, and economic status. At the end of 2007, 21,657 people were members of the YMCA of Central Kentucky, including 441 individual youth memberships, 347 individual teen memberships, 531 college students, 2,671 adults, 17,275 family memberships and 392 senior memberships. Included within the senior membership category were 873 members who were participating in a national Silver Sneakers Fitness Program, which is a unique physical activity, lifestyle, and social oriented program designed to encourage Medicare-eligible (65+) members, often burdened by multiple chronic conditions, to increase their levels of physical activity and motivate them to continue to be active. Silver Sneakers members receive a free basic membership to the YMCA with the opportunity to participate in special low-impact exercise classes. The YMCA supports others in need of the support and friendships gained through membership providing free memberships for participants in the Health Department Smoking Cessation program and for participants in the St. Joseph Smoking Cessation program. The YMCA also provides scholarships for women through the Fayette County Drug Court program (50% paid by the Y, and 50% paid by the Drug Court) and provides staff for educational sessions. The YMCA awarded \$367,073 in direct financial assistance to individuals for participation in YMCA membership.

103A Facility Rental: The YMCA of Central Kentucky partners with a number of agencies and organizations throughout the area for the purpose of building a better community. During 2007 the YMCA provided free and fee-based facility usage for the following groups:

- Bell House – The YMCA provides its swimming pool free of charge for 15-20 senior adults who participate in water exercise four times per week.
- Boy/Girl Scouts – The YMCA opened its facilities to the Scouts for children to obtain merit badges.
- Fayette County Public Schools – The YMCA provided pool rental time for area high school swim teams throughout their seasons.
- Hope Center – YMCA provides showers and temporary shelter when center is full. YMCA provides exercise and recreational time for Hope Center residents.
- Lexmark International, Inc. – YMCA provides rental space for employee basketball league.
- Gainesway Center – The YMCA provided gym and swim space for the Gainesway Center throughout the year.

- SAFE Place – The High Street YMCA serves as a SAFE place for youth needing safe, temporary refuge.
- Lexington Children's Drum Choir – provides space for classes and rehearsals

103B Resident Rents: The High Street YMCA provides housing and shelter, both permanent and temporary, for an affordable fee for people in transition, students and unemployed people. The purpose is to provide a wholesome environment to foster sound character. Use of the YMCA's fitness and recreational facilities is available to residents. During 2007, housing was provided to 49 male individuals for various periods of time.

Other community support

- Thanksgiving Dinner provided for the residents living at the YMCA
- Easter Prayer Breakfast open to anyone in the community
- YMCA staff volunteer time and provide space for CKEEP Income Tax Preparation, serving 82 low-income individuals with tax preparation
- The Beaumont YMCA provided 62 community education certification courses in CPR, First-Aid and the Safesitter program
- The Jessamine County YMCA collaborated with local agencies to host K94Life to raise money for cancer research.

YMCA OF CENTRAL KENTUCKY
POLICY ON MEMBERSHIP FINANCIAL ASSISTANCE

Within the available resources of the YMCA of Central Kentucky, the YMCA will provide services for any youth or adult who desires to participate, regardless of ability to pay the established membership fee.

Those unable to pay the full fee may receive financial assistance based on their demonstrated ability to pay, and the YMCA's ability to fund the subsidy.

How to apply

1. Applicants must fill out the financial assistance form
2. Some form of written verification of income is needed, such as the prior year's income tax return, W2 form, a copy of a most recent paycheck stub, or a letter from employer verifying salary. If the applicant is not employed, verification of this fact must also be supplied. If the applicant is a full-time student, he/she must submit a copy of class registration.
3. The Membership Services Director will make an appointment with the applicant before assistance is awarded. All applicants' records will be kept confidential.

Eligibility

1. Assistance will be granted on the basis of financial need. The YMCA Board of Directors established guidelines for financial support.
2. The YMCA believes a strong sense of ownership and pride is developed if the financial assistance recipient has contributed to the cost of their YMCA involvement. Therefore, applicants will normally be asked to pay a portion of the membership fee.

Selection Process

The membership Services Director will notify all applicant of approval for financial assistance. Applicants who have received approval will have a two-week period to accept the award. All membership assistance is granted for a one-year period.
