Morgan Memorial Goodwill Industries, Inc. ("Goodwill") established Goodwill Headquarters, Inc. ("GHI") as a supporting organization for Morgan Memorial Goodwill Industries which is its sole member. Both entities are 501(C)(3) organizations located at 1010 Harrison Avenue, Boston, MA 02119. Goodwill Headquarters, Inc. owned the headquarters of Morgan Memorial Goodwill Industries and leased it back. In October 2017, loans held by Goodwill Headquarters, Inc. were terminated. The lease with Morgan Memorial Goodwill Industries for the headquarters was terminated and the headquarters was transferred back to Morgan Memorial Goodwill Industries.

The financial statements of GHI have been consolidated with the financial statements of Goodwill in the audited financial statements and all intercompany transactions have been eliminated in the consolidation. Therefore, the IRS Forms 990 for Goodwill and GHI should be reviewed together.
