THE CAMP OFFERS TWO 5-DAY OVERNIGHT RESIDENT CAMP SESSIONS: ONE FOR KIDS (AGES 6 - 12) AND ONE FOR TEENS (AGES 12 - 19). WE ALSO OFFER A 2-DAY DAY CAMP FOR CHILDREN AGES 4 - 7 YEARS, WHICH PROVIDES CAMP ACTIVITIES FOR THESE CHILDREN, AS WELL AS AN ONSITE PARENT ACTIVITY FOR THEIR PARENTS. OUR PROGRAM SERVES CANCER PATIENTS AND THEIR SIBLINGS FROM WITHIN THE REFERRAL AREA FOR PRIMARY CHILDREN'S MEDICAL CENTER, WHICH INCLUDES UTAH, IDAHO, WYOMING, AND NEVADA.
