AND 19 YEARS OLD. THE CAMP OFFERS TWO 5-DAY OVERNIGHT RESIDENT CAMP SESSIONS: ONE FOR AGES 6-11 YRS
AND ONE FOR AGES 11-19 YRS. WE ALSO OFFER A 2-DAY CAMP FOR CHILDREN AGES 4-7 YEARS, WHICH PROVIDES
CAMP ACTIVITIES FOR THESE CHILDREN, AS WELL AS AN ONSITE PARENT ACTIVITY FOR THEIR PARENTS. OUR
PROGRAM SERVES CANCER PATIENTS AND THEIR SIBLINGS FROM WITHIN THE REFERRAL AREA FOR PRIMARY
CHILDREN'S HOSPITAL, WHICH INCLUDES UTAH, IDAHO, WYOMING, AND NEVADA. OVER 90% OF THOSE SERVED BY
CAMP HOBE LIVE IN UTAH, WITH ABOUT 83% RESIDING ALONG THE WASATCH FRONT. CHILDREN OR TEENS
DIAGNOSED WITH CANCER MAY ATTEND CAMP HOBE WHILE THEY ARE BEING TREATED WITH IMMUNOSUPPRESSIVE
