THE CAMP OFFERS TWO 5-DAY OVERNIGHT RESIDENT CAMP SESSIONS: ONE FOR AGES 6-11 YEARS AND ONE FOR AGES 11-19 YEARS. WE ALSO OFFER A 2-DAY CAMP FOR CHILDREN AGES 4-7 YEARS, WHICH PROVIDES CAMP ACTIVITIES FOR THESE CHILDREN, AS WELL AS AN ONSITE ACTIVITY FOR THEIR PARENTS.
