DVU WORKED TO CHANGE THE PUBLIC PERCEPTION OF DISABILITY THROUGH OUR SELF-ADVOCATES SPEAKERS BUREAU MADE UP OF PEOPLE WITH DISABILITIES WHOM WE HAVE TRAINED IN PRESENTATION SKILLS. DVU HAS TRAINED OVER 100 SELF-ADVOCATES. DVU ALSO APPEARED EXTENSIVELY IN THE MEDIA ON A RANGE OF DISABILITY ISSUES WITH THE MOST EXTENSIVE COVERAGE OF THE RACIAL AND ETHNIC INEQUITIES FOR PEOPLE WITH DEVELOPMENTAL DISABILITIES.
