THIS HEPLD THOUSANDS OF UNWANTED KITTENS FROM BEONG BORN INTO A ALREADY HIGH-POVERTY AND OVERPOPULATED REGION. AT THE SAME TIME, WE FOUND NEW HOMES FOR 983 CATS THAT WERE EITHER RESCUED AS STRAYS OR SURRENDERED BY OWNERS WHO COULD NO LONGER CARE FOR THEM.
