**We delivered a wide range of teacher workshops. Working with our partners, we trained a record 1,786 K12 Arizona teachers, of whom 60% are new teachers, reaching more than 200,000 students from 432 schools 80 cities, in all 15 counties of Arizona. Of these 432 schools, 150 schools are first time participants. This bring the total number of schools we have served to more than 1,000! 60% of them have majority of the students from low to moderate income families. ACEE co-hosted the 55th Annual National Financial Literacy and Economic Education conference in Phoenix this year, benefiting more than 100 K-12 Arizona teachers and tens of thousands of students. AZ teachers & students were highlighted at the conference, a proud moment for AZ education.**

**Students respond to participatory learning. Scholarship were offered to 1,000 students from 22 schools. Building upon the success of the annual Economics Challenge and Finance Challenge, we launched the inaugural Mayor's Challenge for Economic Education to include a new competition "Own your Financial Freedom" personal finance case study competition. Schools & students flocked to it, doubling number of partipatory schools. To showcase the diverse student talents and learning of economic literacy, we launched the inaugural poster contest for grad K-8th students to illustrate economic concepts in drawings. More than 100 submissions were received and the top 12 were selected by the community for the 2017 calender.**

**Research shows that most parents do not feel comfortable with or have knowledge to speak with their children about money. This can be especially true with low income families. Responding to the needs of the underserved community and pairing with the teacher training, we brought parents and their children together from low income families the Salt River Indian Reservation and Navajo Indian Reservation to learn and talk about financial literacy after school. The newly launched Invest It Forward Program, which matches teachers in need and industry speacialists, has been well received with opportunity to grow. This year, over 150 volunteers helped us with programs & events, acting as guest speakers & judges.**
