To empower teachers and educate students so that all school-aged children grow up to become economically and financially responsible employees, parents, citizens and leaders in the future.

Teacher training: A record of 1,876 K-12 Arizona teachers, of whom 74% were new to ACEE, were trained to deliver curriculum to more than 200,000 students statewide. The curriculum, aligned with the state Economics and Financial Literacy Academic Standards and valued at \$1.7 million is provided free to the teachers. The result of new partnerships with K-12 school districts and higher ed institutions was the training of 574 teachers alone. The total number of schools served was 1,852 with 61% Title I schools and a significant number of the students from low-to-moderate income families.

4b (Code:) (Expenses \$ **58,453.** including grants of \$ **36,542.**) (Revenue \$ **14,567.**)

Student Programs: Students respond to participatory learning. Building upon the success of the annual Mayors' Challenge for Economic Education, we launched and expanded the competition to include an economics critical thinking presentation where students debated current public policies and issues by applying economic principles. Scholarships were awarded to 1,141 students from Title I schools to participate in the SIMFA Foundation's Stock Market Game curriculum. Research shows significantly higher math and financial literacy test scores by students who participated in this program and thousands of AZ students have benefited every semester. AZ had a first place national winner!

Low Income: Studies show the most parents either lack the knowledge or are uncomfortable teaching their children about money and even more so in low income families. Responding to the needs of the underserved community, we brought parents and their children in after school settings to learn about financial literacy.
