BOARDING SCHOOL PROGRAM: OUR BOARDING SCHOOL PROGRAM SERVES THE REGION'S MOST VULNERABLE AND UNDERPRIVILEGED GIRLS. IN 2015, WE HAD 183 GIRLS ENROLLED IN GRADES 4-8. THE KAKENYA CENTER FOR EXCELLENCE IS COMMITTED TO PROVIDING OUR STUDENTS WITH ALL THE RESOURCES THEY NEED TO EXCEL. THE PROGRAM TAKES A HOLISTIC APPROACH TO EDUCATING RURAL, VULNERABLE AND MARGINALIZED GIRLS BY INCORPORATING HEALTH AND LEADERSHIP ELEMENTS INTO THE CLASSROOM CURRICULUM AND ADDRESSING ALL NEEDS, INCLUDING PHYSICAL, SOCIAL, AND EMOTIONAL AS WELL AS ACADEMIC. OUR DORMITORY ALLOWS GIRLS TO BOARD AT THE SCHOOL RATHER THAN FACE THE DAILY DANGERS OF WALKING LONG DISTANCES TO AND FROM THEIR HOMES. THE BOARDING FACILITY ALSO ALLOWS GIRLS ADEQUATE TIME TO LEARN AND THRIVE IN THEIR STUDIES, AS OPPOSED TO THE BURDENSOME WORKLOADS THEY ENCOUNTER

JILINDE HEALTH AND LEADERSHIP TRAINING PROGRAM: KCE'S JILINDE PROJECT TEACHES YOUNG PEOPLE HOW TO PROTECT THEMSELVES AGAINST HARMFUL PRACTICES, GENDER-BASED VIOLENCE AND LIFE-THREATENING DISEASES; TO PREPARE THEMSELVES WITH AN EDUCATION AND INFORMATION ABOUT MANY OPPORTUNITIES FOR BETTER FUTURE TO REACH THEIR FULLEST POTENTIAL; AND TO PROMOTE ACCURATE INFORMATION AND NEW IDEAS ABOUT SEXUAL AND REPRODUCTIVE HEALTH AND RIGHTS (SRHR) AMONG THEIR FRIENDS, FAMILIES AND COMMUNITIES. NETWORK FOR EXCELLENCE PROGRAM: KCE'S NETWORK FOR EXCELLENCE WAS DEVELOPED AS A WAY TO CONTINUE TO SUPPORT OUR GRADUATES AS THEY TRANSITION FROM PRIMARY EDUCATION AT OUR BOARDING SCHOOL TO SECONDARY EDUCATION IN DIFFERENT HIGH SCHOOLS AROUND THE COUNTRY AND IN THE FUTURE UNIVERSITY AND COLLEGES AROUND THE WORLD. WE ARE COMMITTED TO SUPPORTING OUR GIRLS BEYOND PRIMARY SCHOOL, ENSURING THAT THEY HAVE THE TOOLS THEY NEED TO SUCCEED THROUGHOUT SECONDARY SCHOOL AND BEYOND.
