1. FOREIGN ACTIVITIES:

a. We have estimated expenses paid in Columbia & India based on the activity in each bank account and wages paid.

2. FINANCIAL STATEMENTS:

a. You indicated that the ending cash balances for each bank account have been reconciled. We assume that you are able to explain the differences between the bank statement balance and the balance in the financial statements. The cash balances included in the year end bank statements are about \$18,000 less than the amounts shown in the financial statements. This is a material difference that should be documented and you should be able to explain.

b. Several of the cash accounts in the balance sheet are negative and include (Inactive - WCB Mission (5,325), Online accounts (5,925), Cash on Hand (2,596). I assume you are not truly overdrawn, but rather the accounting system has more expenses recorded than were actually paid through that specific account or were adjusted or offset with the US\$11,641 Petty Cash. Can those accounts be "zeroed out" or adjusted to zero if appropriate?

c. The balance recorded on the Gold Merchant credit card shows you have a credit balance. We did not receive a copy of the general ledger with complete activity including all balance sheet accounts. You should have your bookkeeper review this account to be sure you are recording the activity correctly.

d. I was not able to specifically identify the adjustments that were made to the fund balance after the year ended December 31, 2015. We have included \$6,888 additional expense in the 2016 tax return to roll forward the fund balance to agree to the balance included on the financial statements for the year ended December 31, 2016.

e. We have taken \$73 of depreciation expense in the current year related to the donated table and chairs you received last year. Can you ask your bookkeeper to record the following entry:
