The SNC also provides homes or referrals for many unwanted, abused, or neglected exotic pets. The SNC serves as an information center helping homeowners, businesses and municipalities deal with wildlife problems and rescues. The Center teaches responsible pet ownership and how to pick the correct pet for the right family situation.
