Lending Circles Program to Resources Match online application, MAF has helped
improve the financial capability of immigrants and low-income individuals in California
and across the United States. With MAF's assistance, these individuals have opened
bank accounts at mainstream financial institutions, improved their financial capability,
built their savings and responsibly leveraged credit to invest in homes, citizenship,
education and small businesses. Within the past two years, MAF has successfully
replicated the Lending Circles model with 16 community partners across six states,
