The Senior Companion Program places seniors 55+ who live at or below the federal financial poverty line with other seniors who need a little extra assistance to remain independent in their own homes The companions commit to providing at least 15 hours of service each week and for their dedication are paid a small stipend and are reimbursed for their transportation In 2014, 98 companions served 148 families providing over 68,308 hours of services at no charge to the client These hours saved families and taxpayers over \$1.5m In addition, the program received donated use of facilities and in-kind services with a fair market value of \$29,250 The Senior Companion Program at Shepherd's Center of Kansas City Central has a wait list of over 150 families in need of this service and over 50 Seniors who are interested in serving Additional funding is needed to add more companions to serve additional families

The Meals on Wheels program at Shepherd's Center Kansas City Central (SCC) had a growth spurt in the fall of 2014 as SCC absorbed 100 clients from the discontinued Meals on Wheels program at the City-sponsored Robert Mohart Center, a center in one of the most food insecure areas of Metro Kansas City SCC accepted these clients under its' expanded delivery area This brought the total of daily meal deliveries in October 2014 to 160 meals per day to homebound older and disabled adults Total meals delivered in 2014 were 22,206, and we anticipate that number to double in 2015 SCC is the second largest home delivered Meals on Wheels site in the Greater Kansas City, MO area
