HIKE for Mental Health is committed to a world in which everyone, including those afflicted by mental illness, can experience the simple joy of living. Our mission is to increase public awareness of the challenges and suffering faced by those afflicted by mental illness and their families while also increasing appreciation for and responsible use of wilderness trails. We organize hikes and enable hikers to collect donations which support programs that alleviate the pain caused by mental illness and preserve wilderness trails.

HIKE for Mental Health designated the Brain & Behavior Research Foundation as the recipient of its 2014 award to alleviate suffering from mental illness and disbursed 80% of the donations received from hiker sponsorships to this outstanding organization. Since the Brain & Behavior Research Foundation's operating expenses are covered by two family foundations, 100% of the disbursement we make is invested in NARSAD Grants leading to discoveries in understanding causes of and improving treatments for disorders in children and adults, such as depression, schizophrenia, anxiety, and bipolar, post-traumatic stress and obsessive-compulsive disorders. The NARSAD program is renowned for its track record of funding innovative research that leads to break-through learnings and new methodologies that advance our understanding of brain and behavior disorders.

4b (Code:) (Expenses \$ 11,000 including grants of \$ 11,000) (Revenue \$ 0)

HIKE for Mental Health designated the New York New Jersey Trail Conference and the Pacific Crest Trail Association as recipients of its 2014 award to promote responsible use of and to preserve wilderness trails. As an organizer of hikes on which we promote awareness of the stigma associated with mental illness, we believe it is important to give back a portion of our receipts to maintain and preserve trails and trail systems. In 2014, we awarded 20% of the donations received from hiker sponsorship, or \$5,500 each, to the NJNYTC and the PCTA. The NYNJTC is a trail-maintaining organization in the ATC and is responsible for 2,000 miles of public trails, includes 160 miles of the Appalachian Trail. The PCTA protects, preserves and promotes the 2,650 mile PCT as one of the best trail experiences on Earth.

HIKE for Mental Health dedicated its Veterans Day Walk to alleviating suffering from mental illnesses and emotional distress in our veterans and active duty service men and women. Many of them return from the battlefield but continue to fight internal battles for their mental health and peace of mind. Donations from our Veterans Day Walk support vets and service personnel in two ways. First, in partnership with an Army Medical Center in Texas, \$2,436.60 was dedicated to purchase books, workbooks, videos and other self-help materials for patients of its behavioral ward, which treats primarily active duty service men and women. Second, \$3,000 was disbursed to VFW Post 7109 in Pearland, TX, our local partner and co-sponsor of the Pearland Veterans Day Walk for PTSD Awareness, to aid the VFW Post's effort to increase services offered to veterans and to support their initiative to become a more integral part of the community.
