Sports, Competition and Training- The Organization trains volunteer coaches in working with special needs individuals and in sport specific training instructions. Approximately 50 training schools are held throughout the state to meet these training needs. Athletes participate in a number of the approx. 100 competitions held annually at the local, parish, area and state level, offering competitive events in more than 30 sports. Every other year, athletes can qualify to compete in either the Summer World Games or the Winter World Games, giving them further opportunities to grow and meet new people from other countries and cultures. Various programs including Got SOLA?, Project Unify, Healthy Athletes and the Young Athletes program promote the health and well-being of athletes including intervention of early childhood sports development. In-kind expenses for this activity were \$454,524.
