Athletes participate in a number of the competitions held annually at the local, parish, area and state level, offering competitive events in more than 30 sports. Every other year, athletes can qualify to compete in either the Summer World Games or Winter World Games, giving them further opportunities to grow and meet new people from other countries and cultures. Various programs including Got SOLA?, Project Unify, Healthy Athletes and the Young Athletes program promote the health and well-being of athletes including intervention of early childhood sports development.

Communications & Marketing- The Organization has a goal of transparency and keeping the public informed of the services provided to Louisiana citizens with intellectual disabilities.
