THE MISSION IS TO ADVANCE CHILDREN'S LITERACY SKILLS USING AN ENGAGING CURRICULUM, CERTIFIED DOGS, AND DEDICATED VOLUNTEERS. DURING 2018-2019, SITSTAYREAD'S 16TH YEAR, WITH THE HELP OF 243 HUMAN AND 70 CANINE VOLUNTEERS, SITSTAY READ SERVED 2,283 STUDENTS IN 94 CLASSROOMS THROUGH FOUR DIFFERENT GRADE-LEVEL PROGRAMS IN 18 CHICAGO PUBLIC SCHOOLS. SITSTAYREAD ALSO PARTICIPATED IN COMMUNITY PROGRAMS AND EVENTS, SERVING AROUND 350 ADDITIONAL STUDENTS FOR A TOTAL OF 2,633 STUDENTS.
